## **CONTINENCE AIDS PAYMENT SCHEME (CAPS) – Eligible Conditions**

The CAPS is an Australian Government Scheme that provides a payment to assist eligible people who have permanent and severe incontinence to meet some of the costs of their incontinence products. The payment is made by Medicare directly into a client's nominated bank account. The 2022-23 payment rate for CAPS is up to **\$650.40** per person. <u>https://www.servicesaustralia.gov.au/how-much-you-can-get-continence-aids-payment-scheme?context=21826#a1</u>

An applicant is eligible for CAPS if the applicant is five years of age or older and meets either one of the following requirements:

• The applicant has permanent and severe loss of bladder and/or bowel function (incontinence) due directly to an *eligible neurological condition* and do not require a Centrelink or DVA Pensioner Concession Card

OR

• The applicant has permanent and severe loss of bladder and/or bowel function (incontinence) caused by an *eligible other condition*, provided the applicant has a

- Centrelink or
- DVA Pensioner Concession Card entitlement
